Alcohol-impaired driving is preventable. you can do your part to keep roadways safe with three easy steps.



# STOP

Before choosing to drive under the influence, STOP!
Alcohol use impairs motor skills, judgment, and
coordination. Driving under the influence of alcohol
not only effects you, but everyone around you.

### <u>In Virginia</u>

There were 6,749 alcohol related crashes in 2021.
Of those crashes, 237 were fatal.

67% of DUI convictions were male drivers in 2022.

Alcohol related serious injuries made up 14% of all serious traffic injuries. 6% of these crashes resulting in the death of a person.

### **In Chesterfield County**

In 2022, there were 329 alcohol related crashes.
One hundred and twenty-five of those crashes
involved young adults between the ages of 16-25.

An average of 14.14% of those charged with DUI by Chesterfield County Police between 2018-20 admitted to consuming a drug in addition to alcohol, compared to 10% in 2015-2018.

## THINK

Alcohol impaired driving is a costly choice. Think of the consequences of a DUI before choosing to drive under the influence.

### **Convictions for DUI first offense**

Mandatory, minimum \$250 fine

The court can impose a fine up to \$2,500

**Drivers license revocation for one vear** 

#### **Conviction for DUI second offense**

Mandatory, minimum \$500 fine

**Drivers license revocation for three years** 

Possible jail term for up to one year

### **Under 21**

Virginia has "zero tolerance" laws making it illegal for underage drivers (those under 21 years old) to get behind the wheel with a .02% BAC or more.

If you are under the age of 21 and convicted of driving after illegally consuming alcohol with a BAC between 0.02% and 0.08%, the court penalty will include:

Suspension of driving privilege for one year

Minimum, mandatory fine of \$500, or 50 hours of community service

## PLAN

If you plan to drink, first have a plan in place to Secure a sober ride home. Do not drive under the influence. Make responsible decisions.

#### **Ways to avoid driving under the influence**

Don't drink alcohol or use drugs.

Use convenient rideshare services such as Uber or Lyft.

Use a regular taxi or public transportation.

Assign the role of 'sober driver' to a friend or family member.

If you are impaired, stay where you are until you are sober.

If you think friends may be impaired, encourage them to stay the night.

Stay home and drink responsibly.
